

CONSULTATION AND ABORIGINAL MATTERS

Consultation Program and Vision

Consultation activities for the Project have been and will continue to be conducted in line with the company's consultation program based on the following principles set out in Westcoast's charter:

- Stewardship Demonstrating a commitment to environmental responsibility and vibrant communities.
- Integrity Ethically and honestly doing what we say we will do.
- Respect for the Individual Embracing diversity and inclusion, enhanced by openness, sharing, trust, leadership, teamwork and involvement.
- High Performance Achieving superior business results and stretching our capabilities.
- Safety Sharing a relentless commitment to a zero work-related injury and illness culture.
- Win-Win Relationships Having relationships which focus on the creation of value for all parties.
- Initiative Having the courage, creativity and discipline to lead change and shape the future.

Principles and Goals

Westcoast recognizes the importance of working with all persons and groups who may be potentially affected by any phase of a project. The goals of the consultation program are to:

- identify stakeholders and Aboriginal communities who have interests in the Project area who could potentially be affected by the project as soon as possible in the planning phase;
- inform potential stakeholders and Aboriginal communities throughout the various phases of the Project by sharing information on key project specifics in a clear and timely manner;
- create opportunities for meaningful stakeholder and Aboriginal community engagement as early
 as possible in the project planning process and advise stakeholders of their opportunities to
 communicate with the National Energy Board (NEB or Board);
- understand and respond to any issues or concerns in an effort to resolve or mitigate those issues or concerns; and
- maintain ongoing communications with stakeholders and Aboriginal communities throughout
 the planning, construction and post-construction phases with a view to continued development
 of the long-term relationships required for the operation of the facilities.

Aboriginal Consultation

Westcoast is committed to building and maintaining sustainable, long-term relationships with Aboriginal peoples that are based upon mutual respect and understanding. Aboriginal consultation for the Project has been conducted in accordance with Spectra Energy's Aboriginal Consultation Approach (filed with the Board in May of 2009) which sets out an Aboriginal relations strategy focusing on four key areas:

- relationship building;
- consultation and communication;

- capacity building; and
- economic development.

Consultation Design

Design of Project consultation began with an assessment of the Project scope. Based on the Project scope, a review of local and regional interests in the Project area was undertaken to facilitate the identification of persons or groups who may potentially be affected by the Project. A key consideration was the location of the proposed facilities as well as potential Project impacts and the mitigation measures available to address those impacts. The Project is located on private and Crown land in an area engaged in residential and agricultural activities as well as other oil and gas development. Further, the Project primarily follows an existing Westcoast pipeline right-of-way (ROW).

The local and regional interests identified through the assessment process included:

- Landowners
- Local residents
- First Nations
- Métis
- Holders of registered trap-lines
- Guide/outfitters
- Industry
- Local government
- Provincial and federal government authorities
- Local environmental organizations

In order to identify potentially affected persons and groups, Westcoast sent an information package (Project Information Package) containing a letter, map, Project Fact Sheet, contact information for comments, questions or concerns and the NEB brochure "Information for Proposed Pipeline or Power Line Projects that Do Not Involve a Hearing" to all parties that may have an interest in the Project. From that initial letter and request, as well as known interests in the area, Westcoast identified the following potentially affected parties:

- Aboriginal Communities: Halfway River First Nation, Horse Lake First Nation, Kelly Lake Cree
 Nation, McLeod Lake Indian Band, Saulteau First Nation and West Moberly First Nations
- Landowners
- Local residents
- Recreational users
- Trappers and Guide Outfitters
- Local government: City of Fort St. John, District of Chetwynd, District of Taylor and Peace River Regional District.
- Provincial and Federal Government: British Columbia(BC) Archaeology Branch of MFLNRO
 (Archaeology Branch), BC Ministry of Energy and Mines (MEM), BC Ministry of Forests, Lands

and Natural Resource Operations (MFLNRO), BC Ministry of Transportation and Infrastructure (MoTI), and Transport Canada.

• Industry

Consultation then focused on active engagement with additional Project information, follow-up communications and face-to-face meetings (where requested) to provide further information and receive feedback on the Project. To address the diversity of the region and to ensure broad and inclusive consultation, activities and communication tools have included and will continue to include:

- Face-to face meetings
- Telephone discussions
- Email exchanges
- Site visits

Consultation Program Implementation

Westcoast's consultation activities for the Project commenced in December 2015 with the provision of Project Information Packages and have continued to date with various communications. Recipients were asked to identify any further information required, as well as any issues or concerns they may have with the Project. Recipients were also informed of how they could raise concerns with the NEB.

Appended to section 3 is the Project Consultation Record which provides a summary of specific consultation activities by Westcoast.

The following provides additional details of the consultation activities undertaken to date.

Aboriginal Community Engagement

Westcoast recognizes the importance of ensuring that its ongoing activities and proposed projects, as well as opportunities for local participation and employment, are communicated to Aboriginal communities in a timely manner. Westcoast's objective is to provide opportunities for participation and feedback by Aboriginal communities by ensuring that project information is conveyed to them in writing and, whenever possible, in person.

The Project area within northeast BC is subject to Treaty 8. Westcoast initially provided Project Information Packages to all signatories to Treaty No. 8 in BC, as well as others that may have an interest in the Project, namely BC Métis Federation (BCMF), Blueberry River First Nations (BRFN), Dene Tha' First Nation, Doig River First Nation (DRFN), Fort Nelson First Nation (FNFN), Fort St. John Métis Society, Halfway River First Nation (HRFN), Horse Lake First Nation (HLFN), Kelly Lake Cree Nation (KLCN), Kelly Lake First Nation (KLFN), Kelly Lake Métis Settlement Society (KLCSS), McLeod Lake Indian Band (MLIB), Métis Nation of British Columbia (MNBC), Moccasin Flat's Métis Society, Nun wa dee (Keepers of the Land), Prophet River First Nation (PRFN), Saulteau First Nations (SFN) and West Moberly First Nations (WMFN).

Based on the responses to those letters, as well as Westcoast's knowledge of expressed interest in the Project area, additional consultation and engagement then occurred with a smaller group of communities, namely HLFN, HRFN, KLCN, MLIB, SFN and WMFN. As is Westcoast's practice, if at any time, additional Aboriginal communities express interest in a project, additional consultation and engagement would occur.

Westcoast met with HLFN, HRFN, KLCN, MLIB, SFNf and WMFN regarding the proposed Project to share more detailed information and answer questions. Westcoast will continue to consult with these communities and any other Aboriginal communities potentially affected by the Project.

To date, there are no outstanding concerns from Aboriginal communities.

Landowners

There are twelve landowners whose property is traversed by the Project. Consultation began with initial contact in September 2015 to consult on the proposed pipeline route through each property, to discuss Project overview and proposed timelines and to provide Project Information Packages. During these conversations, permission was obtained to enter onto the majority of private property affected by the route to complete environmental field assessments, archeological studies, surveys and timber assessments. Westcoast's land consultant held follow up face to face meetings with the affected landowners to distribute further Project information and a copy the NEB's booklet, *Pipeline Regulation in Canada: A Guide for Landowners and the Public.* Continued engagement resulted in Westcoast obtaining permission from the remaining private property holders to complete outstanding field assessments.

General questions related to access, compensation and construction impacts have been fielded during discussions with landowners.

Westcoast continues to consult and attempt to resolve any outstanding concerns or issues raised by landowners and will negotiate necessary tenure documentation with landowners. Westcoast is committed to establishing long term relationships with landowners and residents in the Project development areas and will continue to contact landowners and residents throughout the development, construction and operating phases of the Project.

Local Residents

Local residents within the Emergency Planning Zone (650m) of the Project as well as along the main access roads were consulted about the Project. Consultation began by sending out Project Information Packages in December 2015. Westcoast offered to meet or have further discussions with residents if they had any questions, comments or concerns about the Project.

Four local residents have expressed concerns to date. Three of these local residents have property bordering the proposed Project right-of-way. Originally, Westcoast planned to construct the Project continguous to the existing Fort St. John Mainline which traverses these three residents' properties. However during the past year, Westcoast has been denied access for field assessments and

consultation. Westcoast proposed alternative solutions to address concerns such as decreasing the requested permanent right-of-way, avoiding specific areas to maintain the tree shelter belt, attempts to reduce the overall Project footprint, as well as an offer to purchase was presented on one parcel. These efforts have been unsuccessful to date. As a result of the negotiations to date and cumulative conditions, Westcoast has designed the proposed Project route around these three resident's property in an effort to mitigate their concerns.

With respect to the fourth residend who has expressed concerns, discussions to address concerns related to proximity to their water well are ongoing.

Trappers

Project Information Packages were sent to trapline holders in December 2015.

To date, there has been one response from Registered Trapline 722T007, requesting information on potential impacts to his trapping tenure. A telephone conversation took place and a follow up email has been sent with no response.

To date, there are no outstanding concerns.

Guide Outfitters

Project Information Packages were sent to the guide outfitters in December 2015.

To date, there has been one response from Guide Outfitter 701245 requesting further information. A follow up e-mail has been sent, with no response.

To date, there are no outstanding concerns.

Recreational Users

A Project Information Package was sent to one commercial recreation tenure holder in December 2015.

That recreation tenure holder, Recreational Tenure 8003270, responded requesting further information. A meeting was held with the tenure holder in response and no concerns were raised.

To date, there are no outstanding concerns.

Industry

Project Information Packages were sent to facility owners regarding road use and crossings. Permits for crossings will be acquired as necessary from each company.

To date, there has been one response from Canadian National Railway advising that if Westcoast intends to cross its right of way, a formal "Utility Application" will need to be approved in advance. Westcoast will work with Canadian National Rail to obtain required permits prior to commencing construction.

Local Government

Project Information Packages were sent to the City of Fort St. John, District of Chetwynd, District of Taylor and Peace River Regional District in December 2015. A project update was provided on September 8, 2016 at the Peace River Regional District meeting, which included representatives from these local governments.

To date, there are no outstanding concerns.

Government Ministries and Departments

Project Information Packages were sent to Archaeology Branch, MEM, MFLNRO, MoTI and Transport Canada in December 2015.

MoTI responded with a concern in respect of the potential impact of the Project on certain gravel quarries and tenures. Discussions between Westcoast and MoTI to address those concerns are ongoing.

Westcoast has worked and will continue to work with the Archeology Branch to obtain all required permits prior to commencing construction.

Ongoing Consultation

Westcoast's public consultation activities will continue throughout the lifecycle of the Project to ensure that issues are addressed and that all potentially affected parties remain informed and involved. Westcoast will also continue to use established communication tools with stakeholders during the operations phase of the Project, including public awareness and emergency preparedness programs.
