Alliance Pipeline Limited Partnership, by its General Partner, Alliance Pipeline Ltd. (Alliance) Application for Review and Variance of the National Energy Board 21 July 2016 Letter Decision regarding the Prior Period Adjustment Fee (Application) Alliance Request to Extend the Suspension of the RHW-002-2016 Proceeding

On 21 December 2016, the National Energy Board (Board) granted a request by Alliance to suspend the RHW-002-2016 Timetable of Events to allow Alliance and the Canadian Association of Petroleum Producers (CAPP) to conduct discussions toward a possible resolution of the issues raised in the proceeding. Alliance was directed to file with the Board an update on the discussions by 10 February 2017.

In a letter dated 10 February 2017, Alliance indicated that it had reached an agreement with CAPP that established terms for the processing of prior period adjustments in relation to the Alliance pipeline system. A copy of the agreement was attached to Alliance's letter. Alliance stated that implementation of the agreement requires Board approval of certain amendments to Alliance's tariff. Subject to the Board's approval of these tariff amendments, the agreement requires Alliance to withdraw its Application as well as its related application to the Federal Court of Appeal.

Alliance expected that it would submit an application to the Board seeking approval of the tariff amendments no later than 15 March 2017, following consultation with the Alliance Pipeline Shipper Task Force (Task Force). Accordingly, Alliance requested that the Board extend the suspension of the RHW-002-2016 Timetable of Events for this future interim interval.
