**Hearing Order OH-001-2016  
Enbridge Pipelines Inc. (Enbridge) – Line 10 Westover Segment Replacement  
Program (Project)  
Procedural Update No. 2**

In its 16 May 2016 letter, the National Energy Board (Board) invited all Participants of the OH-001-2016 hearing [[A76887](#)] who wished to do so, to submit notices of intent to provide an oral statement or Oral Traditional Evidence (OTE) to the Board during the Community Meeting. Six Nations of the Grand River indicated that it would be interested in presenting OTE at the Community Meeting.

The Board will hear Six Nations of the Grand River's OTE on **Tuesday, 28 June 2016 1:30 p.m.** (local time) in Hamilton, Ontario in the East Ballroom of the Sheraton Hamilton Hotel, 116 King St W. If necessary, questions of clarification will follow.

Participants who did not express an interest in the Community Meeting may be allowed to speak if time permits. You are asked to contact the Board's Process Advisor, Matt Groza as soon as possible if you would like to present at the meeting.

**Questions Following Presentations of Oral Evidence**

It is important to note that Enbridge and Intervenor will be given a short amount of time to verbally ask questions of clarification on the oral evidence immediately after it has been presented. The Board may also ask questions.

**Use of Visual Aids during Oral Evidence**

Visual aids or other written materials referred to during presentations (e.g., a map illustrating traditional land use, or a sacred item) should only be used to assist in interpreting or illustrating the oral evidence. Most written materials are more appropriately filed as written evidence rather than being part of an oral traditional evidence presentation.

The Board will provide equipment to project evidence and other documents from the registry on a screen in the hearing room. Therefore, in order to ensure an efficient process, the Board requests that those who wish to refer to evidence already filed on the record identify and submit this information to the Board ahead of the Community Meeting. You may refer to any filed evidence, regardless of the participant that filed it. You are not limited to referring only to evidence that you or your group has filed.

Parties referring to any electronic exhibits are requested to provide the information to Sharon Wong, Regulatory Officer, [Sharon.Wong@neb-one.gc.ca](mailto:Sharon.Wong@neb-one.gc.ca), by **5 pm, Calgary Time, 22 June, 2016. You can provide Ms. Wong with an electronic copy of the table or the information contained in the table in the body of the email.**

Please note that you do not have to accompany your oral statement or OTE with visual material and that the Board will be familiar with any written evidence filed on the public repository.
