# Hadhad family launches factory in Antigonish

How sweet it is.

Just more than seven months after arriving in Canada, Assam Hadhad has reached another important milestone with his small business.

He and his family — the first Syrian refugees to arrive in Antigonish — hosted a celebration Aug. 10 to mark the opening of the Peace by Chocolate production facility.

Nestled in the corner of their Bay Street yard, with more than 100 well-wishers on hand, Assam and his son, Tareq, cut the ceremonial ribbon in front of the rustic-looking shed, which now houses the equipment used to make chocolaty treats that have been leaving people wanting

"It gives us hope again," Tareq said of the fledging, but evergrowing, business.

The son, who spoke on behalf of his father and family, described the occasion as an opportunity to "celebrate a new achievement," in the place they "now call home."

Since the family left Syria, Tareq said his father has been "anxious to start from zero," fulfilling his desire to renew his passion and to start giving back to their adopted home.

Assam owned a chocolate factory in their native Damascus. Employing 30 people, the business shipped product throughout the Middle East.

Tareq noted what took his father 30 years to build was wiped out in a week because of the war in

making chocolate in March, and then selling it at the Antigonish Farmers' Market and other ven-

It wasn't long before more and more people started to nibble, including those at high-profile events, such as the St. F.X. President's Dinner and a provincial Liberal party annual general meeting.

'We are impressed with how well we have been doing," Tareq

The chocolate-making started

in the kitchen of their home. "My mother (Shahenaz) finally said this is not a factory; move to the basement," Tareq said to laughter from the crowd.

They made the move, while production continued to increase. With the help of volunteers, the 16X10 building is now the location

for making their sweet treats.

Tareq said they have big dreams of what they will be able to accomplish, including giving back to their new home of Canada, especially Antigonish, which has welcomed them with open arms.

As a reflection of their focus on giving thanks, the Hadhad family

donated profits from one month of chocolate sales to the Fort McMurray fire relief effort.

They also plan to start employing people, including St. F.X. students.

### **BIG HIT**

Central Nova MP Sean Fraser described the opening as a "terrific occasion," noting the volunteer effort provided in not only bringing Syrian refugee families, such as the Hadhads, to the Antigonish area, but also in helping them prepare for the launch of the chocolate business.

"I couldn't be more proud," he

Fraser added the Hadhads are a "particularly heartwarming story."

After he spoke, Tareq offered him a chocolate. Of course, without hesitation, Fraser accepted. He noted his selection — a piece shaped like a maple leaf was fitting.

Janet Becigneul read a message on behalf of Antigonish MLA Randy Delorey, who could not attend the opening. He was scheduled to tour the facility a couple days later.

"It is another step and a new level in your success," Delorey

He recalled tasting their chocolate for the first time at a Cultural Connections potluck in Antigonish, describing the treats as a "big

Noting he helped make the chocolate part of a provincial Liberal function earlier this year, Delorey said people who attended continue to ask where they can get more.

He added his Antigonish office has fielded requests from as far away as Ontario.

### BIG DEAL

Peter Wade, one of the volunteers who helped construct the chocolate factory, called the milestone a

"It feels like you have been here for years," he said, in reflecting the effect the Hadhad family has had on Antigonish.

Wade added he was pleased to be "a small part of what you have accomplished here."

"I will do quite a bit for chocolate, but even more for peace," he said to applause.

Visitors not only enjoyed plenty of tasty treats, but also a variety of Syrian foods, along with taking tours of the newly unveiled facil-

"We want to thank the whole community for its support," Tareq said.

# Amtrak taps former freight railroad head to be new CEO

WASHINGTON (AP) — The former head of the Norfolk Southern freight railroad, Charles "Wick" Moorman, has been tapped to be president and CEO of Amtrak, the nation's passenger railroad, Amtrak officials said Friday.

Moorman's ties to the freight rail industry should help strengthen the company's relationships with those railroads, said Anthony Coscia, Amtrak's chairman.

Amtrak owns most of the track it operates on in the busy Northeast Corridor, but throughout most of the rest of the country it operates on tracks owned by freight railroads. Amtrak envisions creating a network of interconnected rail corridors that would allow the company to expand passenger service to more communities.

"A big part of Amtrak being able to realize the vision that we think accommodates the kind of growth that we see in passenger rail requires us to get to a partnership with freight railroads that creates maybe a different operating environment than the one that exists today," Cosica said in an

interview. "I can't think of a better person to spearhead the effort than someone who was a real leader in the freight industry and who understands the passenger rail industry," he said.

Moorman, a native of Hattiesburg, Mississippi, was president and CEO of Norfolk Southern Railway from 2004 to 2013.

He succeeds Joseph Boardman, a former head of the Federal Railroad Administration, who has led Amtrak since 2008. Boardman announced his intention to retire last fall.

Amtrak carries operates more than 300 trains daily and carries more than 30 million passengers a year. It connects more than 500 destinations in 46 states, the District of Columbia and three Canadian provinces.
