

## LICENCE GL-338

**IN THE MATTER OF** the *National Energy Board Act* (Act) and the regulations made thereunder;

AND IN THE MATTER OF an application dated 11 February 2016 (Application) by AltaGas LPG General Partner Inc. on behalf of AltaGas LPG Limited Partnership (AltaGas LPG or Applicant) under Part VI of the Act for a licence to export propane filed with the National Energy Board (Board) under File OF-EI-Gas-GL-A792-2016-01 01.

**WHEREAS** the Board directed AltaGas LPG to publish a Notice of Application and Comment Period (Notice) in English and French in the *Globe and Mail* and *La Presse* and to serve the Notice on persons and agencies identified by the Board;

**AND WHEREAS** the Board received a submission from the District of Port Edward with regard to the Application;

**AND WHEREAS** the Board has considered the Application and all related submissions, and is satisfied that the quantity of propane to be exported does not exceed the surplus remaining after due allowance has been made for the reasonably foreseeable requirements for use in Canada, having regard to the trends in the discovery of propane in Canada;

**AND WHEREAS** the Governor in Council (GIC) by Order in Council No. P.C. 2016-1165 dated the 16 day of December 2016 has approved the issuance of this Licence;

**NOW THEREFORE** the Board, under section 117 of the Act, hereby issues this Licence to AltaGas LPG for the exportation of propane subject to the following terms and conditions:

## General

1. AltaGas LPG shall comply with all of the terms and conditions contained in this licence unless the Board otherwise directs.

## Licence Term, Conditions and Point of Export

- 2. Subject to Condition 3, the term of this licence shall commence on the date of first export and shall continue for a period of 25 years thereafter.
- 3. This Licence shall expire 10 years from the date of GIC approval of the issuance of the Licence if the export of propane has not commenced on or before that date, or the Board otherwise directs.
- 4. The maximum quantity of propane, inclusive of tolerance, that can be exported by AltaGas LPG under the authority of this licence is:
  - a. 2.670 10<sup>6</sup> m<sup>3</sup> annually, in any 12-month period; and
  - b.  $66.735 \cdot 10^6 \text{m}^3$  for the term.
- 5. The point of export shall be at the outlet of a marine export terminal located near Prince Rupert, British Columbia and from points along the Canada-United States border where railway crossings occur (specifically: Coutts, Alberta; and Kingsgate, Huntingdon and White Rock, British Columbia).
