**Trans Mountain Pipeline ULC (Trans Mountain) – Complaint by
U.S. Oil & Refining Co. (U.S. Oil) Respecting the Allocation of Capacity
Among Uncommitted Shippers Nominating to Barges
U. S. Oil Extension Request dated 26 January 2017**

On 24 January 2017, the National Energy Board issued Ruling No. 1 and Order PO-001-2017 allowing for the confidential submission of several responses to information requests.

On 26 January 2017, U.S. Oil filed a letter requesting that the deadline for its written argument be extended to 31 January 2017. U.S. Oil cited the delays in receiving the confidential information as justification for the request. On 26 January 2017, Trans Mountain filed a letter stating that it consents to the requested extension.

The Board has decided to extend the deadline for U.S. Oil's written argument to 31 January 2017. The remaining deadlines for written argument by interested parties and for reply argument by U.S. Oil are also extended, as follows:

- U.S. Oil must file written argument by 31 January 2017.
- Interested parties must file written argument by 7 February 2017.
- U.S. Oil must file its reply argument by 14 February 2017.
