Condition 12(a): Training and Education Monitoring Plan

The text of Condition 12(a), as established by the Board, is as follows:

- a) Trans Mountain must file with the NEB for approval, **at least 6 months prior to commencing construction**, a plan for monitoring the implementation and outcomes of Aboriginal, local, and regional training and education measures and opportunities for the Project. The plan must include:
 - i) a description of, and rationale for selecting, the indicators that will be monitored to track the implementation of training and education measures and opportunities;
 - ii) the monitoring methods and schedule, including information and data sources for the indicators being monitored; and
 - iii) plans for consulting and reporting on the implementation and outcomes of training and education measures and opportunities with Appropriate Government Authorities, potentially affected Aboriginal groups, business, industry, and education and training organizations; and
 - iv) a summary of consultations with Appropriate Government Authorities, potentially affected Aboriginal groups, business, industry, and education and training organizations on the development of the plan.

Appendix A to this letter includes a concordance table that shows where each aspect of the Condition is addressed in the attached material.

Summary of Material Filed

Appendix A to this letter includes the following document:

- Training and Education Monitoring Plan for the Trans Mountain Expansion Project: NEB Condition 12a (February 14 2017), hereinafter the “Report”

Trans Mountain’s goal is to maximize employment and business opportunities for Aboriginal, local and regional groups along the Project route. The Report is one of several documents that outline Trans Mountain’s overall approach to addressing, monitoring and reporting on socio-economic effects and opportunities associated with the Project. The Report is structured to address each element of Condition 12(a), as set out above.

Other relevant socio-economic documents which should be read in conjunction with the Report include filings in relation to Conditions 11, 13, 58 and 107. The relationship between these socio-economic effects documents is outlined in Figure 1 of the Report.

A summary of public feedback on training and education related issues pertinent to the Report received between May 2012 and June 2015 was submitted to the Board with the Project application and in subsequent filings. Table 11 in the Report provides a summary of the key themes from that feedback, which helped guide – and were considered in the development of – the Report. No new issues or concerns with respect to education and training were identified by the public through engagement and communication opportunities during the July 2015 to December 2016 period.

The Report is being shared for formal consultation with appropriate government authorities, potentially affected Aboriginal groups, business, industry, and education and training organizations (which began in January 2017). Trans Mountain has requested feedback by March 31, 2017, which it will use to make modifications to the Report as appropriate. As part of its filing in compliance with Condition 12(b), Trans Mountain will provide any updates or revisions to its Training and Education Monitoring Plan that arise as a result of this consultation.
