On February 26, 2015 the National Energy Board (NEB or Board) issued Order XG-N081-008-2015 approving the construction and operation of the Project pursuant to section 58 of the *National Energy Board Act* (NEB Act).¹ The Livingstone Creek Receipt Meter Station portion of the Project was completed and placed in-service on August 7, 2015. On December 5, 2016, the Board issued the Amending Order which approved the variance to the Order as it pertained to the Livingstone Creek No. 2 Receipt Meter Station portion of the Project.²

NGTL applies for Leave to Open (LTO) for the Livingstone Creek No. 2 Receipt Meter Station portion of the Project under section 47 of the NEB Act following completion of its hydrotest program.

The documents to support this LTO Application (see Table 1) were prepared in accordance with Guide T of the Board's Filing Manual. The supporting documents, under Tab A through Tab C, attached, constitute the materials required by the Board for its review and consideration of NGTL's LTO Application. NGTL notes that there were two fewer untested field welds than what was indicated in NGTL's February 12, 2015 response to NEB IR No. 1.3.³ All tested field welds have been pressure tested in accordance with *Canadian Standards Association Z662-15: Oil and Gas Pipeline Systems*.
