**ORDER AO-008-GC-113**

**IN THE MATTER OF** the *National Energy Board Act* (NEB Act) and the regulations made thereunder; and

**IN THE MATTER OF** the variance of the Certificate of Public Convenience and Necessity GC-113 (Certificate) under section 21 of the Act for the removal of the Burnt River Receipt Meter Station approved under Order XG-N081-001-2016 under File OF-Fac-Gas-N081-2015-23 01.

**BEFORE** the Board on 4 April 2016.

**WHEREAS** the Board received an application from NGTL, pursuant to section 58 of the NEB Act and section 43 of the *National Energy Board Onshore Pipeline Regulations* (OPR), dated 27 October 2015 to construct and operate the Burnt River Receipt Meter Station Replacement (Project);

**AND WHEREAS** the Board has issued Order XG-N081-001-2016 (Order) pursuant to section 58 of the NEB Act and section 43 of the OPR, the effect of which is to approve the Project;

**AND WHEREAS** on 2 July 2015, the Board issued Amending Order AO-007-OC-113 and being the last Amending Order to be issued with respect to Certificate GC-113 with pending approval from the Governor in Council;

**AND WHEREAS** the Board has determined that it is in the public interest to vary the Certificate to correctly reflect the removal of the Burnt River Receipt Meter Station facilities from the Certificate;

**AND WHEREAS** the Governor in Council, by Order in Council No. P.C. 2017-88 dated the 3 February 2017, has approved the issuance of the Amending Order of Certificate GC-113;

**IT IS ORDERED THAT**, pursuant to subsection 21(2) of the Act, that Certificate GC-113 is amended to reflect the removal of the Burnt River Receipt Meter Station.
