**Re: Trans Mountain Pipeline ULC (“Trans Mountain”)
Trans Mountain Expansion Project (“TMEP” or “Project”)

Section 34(1)(b) notice re-publication and errata**

In Trans Mountain’s letter dated May 15, 2017 ([A83552](#)) to the National Energy Board (“NEB” or “Board”), Trans Mountain committed to: (1) re-publish its notices under section 34(1)(b) of the *National Energy Board Act* (“NEB Act”) for the Project; and, (2) file a list of required revisions to the Plan, Profile and Book of Reference (“PPBoR”) documents (the “Errata”). This information is provided in this letter.

1. Section 34(1)(b) Notice Re-publication Schedule

Trans Mountain received feedback that some stakeholders require more time in order to review its PPBoR for the Project and to potentially file statements of opposition under section 34(4) of the NEB Act, as detailed in Trans Mountain’s May 15, 2017 letter. As a result, Trans Mountain voluntarily committed to re-publish its section 34(1)(b) notices for all PPBoR segments for the Project. Persons wishing to file statements of opposition in accordance with section 34(4) of the NEB Act, will then have thirty days following the relevant new publication date to file a written statement. Trans Mountain’s proposed publication schedule is attached as Appendix 1. Trans Mountain will also post this schedule on its website for the Project.

2. Errata

In conjunction with its plans to re-publish section 34(1)(b) notices, Trans Mountain has completed a review of the PPBoR to identify any errors or omissions in the PPBoR documents and has identified the required Errata. The list of Errata is attached as Appendix 2 and corrected PPBoR pages are attached as Appendix 3 to this filing. As stated in Trans Mountain’s May 15, 2017 letter, Trans Mountain commits to: (1) inform any landowners affected by the Errata and serve corrected section 34(1)(a) notices, as necessary; (2) incorporate the Errata in the re-publication of section



34(1)(b) notices, as necessary; and, (3) provide PPBoR host locations with copies of corrected PPBoR pages, prior to re-publishing associated section 34(1)(b) notices, as necessary.
