ORDER GO-81-2010

IN THE MATTER OF the *National Energy Board Act* (the Act) and the regulations made thereunder; and

IN THE MATTER OF an application by Pittsfield Generating Company, L.P. (the Applicant) for an order pursuant to subparagraph 15(a)(i) of the *National Energy Board Act Part VI (Oil and Gas) Regulations* (the Regulations) filed with the National Energy Board under File OF-EI-Gas-GO-P167 01.

BEFORE the Board on 30 August 2010.

WHEREAS the Applicant filed an application on 27 August 2010 for an order authorizing the exportation of gas;

AND WHEREAS the Board considered the said application;

IT IS ORDERED THAT the Applicant be and is hereby authorized, under subparagraph 15(a)(i) and section 16 of the Regulations to export gas subject to the following terms and conditions:

- 1. The term of this Order shall commence on 9 September 2010 and end on 8 September 2012.
- 2. The Applicant must comply with:
 - (a) the Act and any regulation made under it, and
 - (b) any order that applies to the holder of this order made under the Act.
