NOVA Gas Transmission Ltd. (NGTL) - Application to Decommission Alberta System Meter Stations and Associated Laterals Pursuant to Section **45.1** of the *Onshore Pipeline Regulations* (OPR) **Aboriginal Group Consultation Directive**

On 24 May 2013, the National Energy Board (Board) received an application from NGTL to decommission Alberta System meter stations and associated laterals (Project) pursuant to section 45.1 of the OPR.

The Board completed a Traditional Territory Analysis on the Project and identified Aboriginal groups who have asserted traditional territory in the Project areas who were not consulted. On 15 July 2013, NGTL filed their response to the Board's Information Request No. 1.2 – Identification of Aboriginal Groups. In that response, NGTL indicated notification was not required for the identified groups. The Board is not satisfied with NGTL's justification for not consulting all Aboriginal groups who have asserted traditional territory in the project areas.

The Board expects companies to consult with all potentially impacted stakeholders throughout the lifecycle of a project. The following Aboriginal groups should have been notified of the Project and provided the opportunity to raise any concerns they may have about the Project with the company:
