[N] Volumes directed to the Alida Terminal that re-originate for further transportation to Cromer, Manitoba will be invoiced the difference between the toll from the originating upstream receipt point to Cromer, Manitoba and the toll from the Alida Terminal to Cromer, Manitoba.

**Battery Low Volume Minimum Charge.** All tolls are subject to the Battery Low Volume Minimum Charge of \$3,000 per month per battery.

**Intra-System Transfers.** The charge payable by both the Transferor and the Transferee in respect of an intra-system transfer shall be \$100.00 for each Enbridge Pipelines (Westspur) Inc. transfer.

**Non-Performance Charge.** The Non-Performance Charge in respect of the Pipeline System shall be \$10.50 / m<sup>3</sup>.

<sup>1</sup> **Discounted Tolls.** Shippers will be eligible for a discounted toll by meeting at least one of the following two requirements: 1) ship 3,180 m<sup>3</sup> (20,000 bpd) or more on an annual basis; 2) make a volume commitment to Westspur of no less than 159 m<sup>3</sup> (1,000 bpd) on an annual basis.
