Loss Allowance	[U] 0.10%	Under this tariff, a deduction will be made by the Carrier to cover losses inherent in the transportation of Crude Petroleum.
Excess Basic Sediment, Water (BS&W) Surcharge (\$/m ³)	[U] \$2.20	Where Crude Petroleum is received at BS&W levels in excess of limits specified in the Rules and Regulations.
Intra-System Transfers	[U] \$200.00	Under this tariff, a charge is payable by both transferor and transferee in respect of each intra-system transfer.
LMCI Abandonment Surcharge (\$/m ³)	[I] \$0.99	Under this tariff, a deduction will be made by the Carrier to cover the future cost of abandonment as a result of the Land Matters Consultation Initiative (RH-2-2008, MH-001-2013).
Electronic Reporting Services (\$/m ³)	[U] \$0.10	Under this tariff, a deduction will be made by the Carrier to cover cost of Electronic Reporting Services.

Governed by the rules and regulations published by:

Plains Midstream Canada ULC's Tariff N.E.B No. 49, supplements thereto and successive issues thereof and on file with the National Energy Board.

The tolls of Carrier are regulated by the National Energy Board on a complaints basis. Carrier is required to make copies of tariffs and supporting financial information readily available to interested Persons. Persons who cannot resolve traffic, tolls and tariff issues with Carrier may file a complaint with the NEB. In absence of a complaint, the NEB does not normally undertake a detailed examination of Carrier's tolls.
